- 7. Report on Colorado River Native Fish Conservation Area Advisory Council Meeting--UT and TPWD are preparing Native Fish Conservation Areas. First area is Colorado River... This is part of Great Plains Landscape Conservation. Working from models and information identifying species of greatest conservation need to determine river segments with most bang for buck in terms of restoration. Maps have been created for entire state. ... The next step is to prioritize where are the river segments that need to restored or kept clean/who the is the lead organization/what is the issue ie: dewatering, exotics, etc/ and provide guidance on sources of funding...
